

Dear Friends,

Though the media spotlight on the conflicts in Iraq and Afghanistan has dimmed, many severely injured Veterans are still waging their own battles right here at home.

According to the Department of Veterans Affairs, over 2,000 Service Members have returned from the wars in Iraq and Afghanistan with catastrophic injuries including multiple limb amputations, spinal cord injuries involving partial or full paralysis, and severe traumatic brain



Now in their 30's and 40's, this population of Veterans is finding it increasingly difficult to adapt and overcome while living in their barrier-filled homes. Inevitably we all must get older, but the aging process and the medical problems that develop with age are accelerated for combat amputees and those who survived severe burns or TBI. Mobility is rapidly declining, and so too is the quality of life for these Veterans and their families who have sacrificed so much for our freedom.

This explains why, 15 years after HFOT first opened its doors, hundreds of severely injured Veterans are applying to our program – still. And we remain as steadfast in our resolve to fulfill our obligation to Build Homes and Rebuild Lives for these deserving men and women in need of adapted homes today, and for those Veterans in the future. But we will need your continued support.

HFOT builds more than just homes...we build a foundation of lifelong success for these warriors and their caregivers. Not only have our adapted homes been proven to enhance quality of life for these Veterans and their families, but our society benefits too when these men and women can continue to recover in a safe environment, stay healthy, and continue their work of serving others and their community. Our impact data shows the causal effect and the collective good that happens when Veterans receive a fully accessible and mortgage-free home... what's even more compelling is when you read about each of the stories behind this data.

I'm pleased and honored to share this newsletter with you in time for Veterans Day 2019, and provide just a glimpse of the impact and outcomes you have helped us accomplish for hundreds of Veterans. You should be extraordinarily proud of the work we are doing together to honor America's Veterans and their families, and advance our mission of Building Homes... Rebuilding Lives.

# STROKES OF FREEDOM

As a child, Mario Lopez loved exploring his creativity through all kinds of art mediums including woodworking, drawing, and painting. One of his earliest memories is of his mother drawing Miss Piggy and Kermit the Frog, and watching in awe as she made the characters come to life as puppets.

Art was a large part of Mario's life until August 2005 when he was severely injured while serving in Iraq. Following an improvised explosive device (IED) blast, Army Sergeant Lopez sustained burns to 50 percent of his body; lost his sight in his right eye; and, most devastatingly, lost his right arm (his dominant one), and four fingers on his left hand. Mario was discouraged at the prospect of never painting again, but he did not have the time to dwell on it during his recovery. "I could not even think about art anymore. I was just trying to survive and live one day at a time – art was not a big part of my life," he says.

A few years later, Mario moved into a new home and was excited to decorate it with original artwork, but quickly learned paintings were expensive. He decided to follow the lead of one of his friends who displayed his own artwork in his home. "I was amazed at his radical idea – that he didn't even have to ask anybody to make an image. He went to the local craft store and bought the supplies, created it, and then hung it on his wall," Mario says.

Getting back into painting, Mario immediately remembered why he loved making art and realized how beneficial it was to his recovery. He taught himself how to paint using his left arm, and started making pieces for himself and friends and family. Now his work is displayed all across the country and he is creating a Veteran art show. "Painting helps me get my mind off my injuries. To have an idea, no matter the challenge, and bring it into an image and into existence is very rewarding," he says.

Mario's inspiration for his work mainly comes from his faith and his surroundings. "I paint anything that I see that I feel the rest of the world should know about. Every artist has to have that creative courage."

Art has not only given Mario professional recognition, it also led him to his wife Danielle. The two started talking partly because of Danielle's interest in Mario's artwork. Mario and Danielle now have four children and wrote a book together called *How I Know:* A Story to Strengthen Your Faith.

Though Mario is making a name for himself as an artist, the challenges he faces in his current home prevent him from going even further in his career. He has trouble using the cabinets in his kitchen, and often loses his balance stepping into the shower.

Mario often becomes disheartened when these obstacles limit the time he can spend with his family and hinder his creative process. "Having an HFOT home will help me and my wife do things around the home more efficiently, and give me more time in the day to focus on my art career with a family of six souls," he says. "Receiving a donated home will give my family a secure footing for the future no matter what life's circumstances may have in store for us. Having a forever home will help me and my family feel like we have a place in this world where we truly belong."

Mario is grateful to HFOT's donors and supporters for giving him the opportunity to achieve the American

Dream. "Your goodwill toward your fellow man will echo and reinstate into future generations, and shift the perspective to undoubtedly honor the Service Men and Women of this great country."

We will be building a home for Mario and his family in New Braunfels, Texas in 2020. Mario created this year's holiday card for Homes For Our Troops.

#### Benefits of giving through your IRA - Tax Wise Option for Donors 70 $\frac{1}{2}$ and Older

#### **Your Qualified Charitable Deduction Benefit (QCD)**

- QCDs allow the donor to transfer up to \$100,000 annually
- QCD counts toward your required minimum distribution (RMD) for the year
- QCD gifts are transferred from an account directly to HFOT
- QCDs are excluded from gross income for federal income tax purpose on your IRS Form 1040

#### To be eligible for your Qualified Charitable Deduction (QCD)

- You must be 70 ½ or older at the time of the gift
- Transfers must be made directly from a traditional IRA by your IRA administrator. Ensure that your information is on the check, in order to properly acknowledge the IRA gift
- The distributions cannot go to a donor-advised fund or life-income gifts, such as charitable remainder trusts or gift annuities
- Gifts must be outright and the donor cannot receive any goods or services in exchange for their contribution

## A NEW CHAPTER

Jennie Hendrickson was filled with gratitude and emotion on the day she and her husband, Navy PO3 Justin Hendrickson, received the keys to their new specially adapted custom home in Pennsylvania, Aug. 3, 2019. In her speech below, she shares her deep appreciation for Justin and how much their new home means for their future.

"I am so proud to be married to someone who is so patient, so kind and so loving. Justin and I have been married for 12 years. Some days have been good, and some days haven't. But we carry every day with us because this makes us how we are today; honestly, I wouldn't want it to be any different. God blessed both of us with second chances at a new life.

Today, I want to speak not as a home recipient and not as Justin's wife, but as a person who has watched this man grow; who has succeeded, who has taken his very hard past and turned it into his future to teach others. Justin has endured things that I could never imagine. Yes, I survived brain cancer and am now in remission, but he had to take care of me and everything in our house. In a marriage, this is probably the worst-case scenario for your spouse. And it hurt me to know that here he is, fighting again for something, and for someone, just like I had to.

While he was in the Navy serving with Marines as a corpsman, I can't relate to the thought of having friends that are a part of a close knit bond, a brotherhood, and they would fight and die for each other if that time had to come. That is foreign to us civilians unless you have seen war. Being in the military was the freedom Justin needed to see the world, and to see the world differently now than the rest of us do.

In the midst of having so much to go through when Justin was injured, is something that many Veterans still have to go through today. Can you imagine, let alone understand, what that must have been like, and then to try to put all of that to rest? Many Veterans never leave the destruction, never leave the death of their friends, and are forced to save all the PTSD that comes with it for when they get out. Justin lost one of his friends that day and he was not able to help him because of his wounds. He directed everyone to hold their ground, with everyone injured and they made it out - I cannot imagine what it takes to find any sort of strength in the face of danger and possible death. Justin has seen and been through so much. Justin – you have honor.

Justin graduated with a bachelor's degree in nursing and a master's degree in education and leadership. He works two jobs. Three times a year he is asked to teach second year military students at the Wounded Warrior Panel at Walter Reed. I hear his story from Iraq every time he is in the classroom. He teaches others about what happened to him physically, mentally, and medically, and what these students from every branch of the military should be thinking about now as they learn and grow. You can see that he makes a big impact to them and you know that they won't forget what he taught them.

He has been and will always be successful because he is so driven and appreciates the life he has. He is a very positive person. He always wants to make things better, and easier. He is definitely someone to look up to. He has an old soul and is very wise beyond his years. I have learned so much from Justin. Sometimes, I wonder why he chose me to be his wife. I am a simple woman, and Justin likes to stir things up a bit.

Justin, thank you for being someone that we all can look up to...to teach us, to understand, to love and for the endless possibilities that you show and share with others. That, anyone's life isn't just for settling. There is way more out there in the world than people can think of and showing people not to be scared and go for it! Thank you for thinking outside the box, always – even though I give you the side eye with a smile when you come up with your crazy ideas. Thank you for sharing and for challenging me and others. Thank you for, being honest, true to yourself and making people laugh. The world needs more people like you! And most of all, thank you for loving me. Because even though I tried to keep this letter 'unbiased,' you need to know that so many people here love you, and I most of all. I thank our Heavenly Father for you every night when I pray. You are my life, my love, my strength and my everything. We've helped each other through our worst times and have celebrated during the best times. HFOT is giving us a new chapter, and I am gladly taking this next step with open arms and new possibilities with you. I love you always and forever. Thank you for being you."
